# Highly Pathogenic Avian Influenza Ontario Update

## February 11, 2025

On behalf of the Feather Board Command Centre (FBCC), the following provides important updates regarding the highly pathogenic avian influenza (HPAI) situation in Ontario.

## THE CURRENT SITUATION

As of February 11, 2025, the Canadian Food Inspection Agency (CFIA) has confirmed the presence of HPAI, subtype H5N1 on eight (8) premises in Ontario in the following regions (click on the location name to access the most recent data for each zone):

- IP 50 <u>Strathroy-Caradoc PCZ 252 Security Zone</u>
- IP 51 Oxford County PCZ 253 Security Zone
- IP 52 and IP 53 Oxford County PCZ 254 Infected Zone + Restricted Zone
- IP 54 <u>Town of Strathroy PCZ 255-Security Zone</u>
- IP 55 Oxford County PCZ 256 Infected Zone+ Restricted Zone
- IP 56 <u>Middlesex County PCZ 258 Infected Zone + Restricted Zone</u>
- IP 57 Wellington County PCZ 259 Security Zone

CFIA has declared primary control zones (PCZ) around infected premises and establishes movement control measures and permitting processes for movement into, out of, within, or through primary control zones. Progress is being made on all infected premises and movement control measures are being adjusted as each premises and associated control zone reaches milestones in the zone revocation process

Across Canada, there are 38 active cases of HPAI in poultry flocks. There have been 4 HPAI detections in poultry flocks in Canada in the last 30 days. Details can be found <u>here</u>. ### **CRITICAL REMINDER FOR ALL POULTRY FARMERS & INDUSTRY STAKEHOLDERS**

FBCC reminds the entire Ontario poultry industry that while progress is being made on each of the sites, we strongly encourage all to follow heightened biosecurity measures (found <u>HERE</u>). Farmers are reminded that they should have appropriate biosecurity personal protective equipment (PPE) available for themselves, their employees and anyone entering their premises.
